



## Personal Information Collection Statement and Agreement

This Personal Information Collection Statement and Agreement (hereinafter referred to as the "Agreement") is made by SPACE Concept Ltd. ("SPACE") in accordance with Article 8 of Personal Data Protection Act ((hereinafter referred to as the "Act"), by which SPACE shall clearly inform you of the following issues and urge your careful review:

### 1. Purposes of Collection

SPACE collects your personal information to meet the needs of membership management, marketing and any rights and obligations based on other agreements SPACE and its members. (Specific Purpose Codes No. 090 Consumer, Customer Management and Service, 040 Marketing (including financial cross-selling business), 069 Contract, contract-like or other legal relation matters)

### 2. Classification of Personal information:

- (1) Type of identification (e.g. Name, I.D. Card number, Address, phone number, E-mail address, Photograph, The number and name for financial institution's account, The number of credit card or debit card and any other number or account of individual, etc.)
- (2) Type of characteristic (e.g. Age, Gender, Date of Birth, Height, and Weight, etc.);
- (3) Family;
- (4) Record of health; and,
- (5) Other information detailed in the relevant purposes of collection. (Codes No. C001 Type for identifying individuals, C002 Type for identifying finance, C003 Type for identifying in government data, C011 Individual description, C012 Physical description, C021 Family, C111 Record of health)

### 3. Time Period, Territory, Recipients and Methods of the Use of Personal information:

- (1) Time Period: Retention period in accordance with the relevant laws/regulations or in line with business needs of SPACE.
- (2) Territory: Location of SPACE and the locations of the business office of SPACE's partner institutions.
- (3) Recipients: SPACE (including the affiliated company, associated company), affiliated short-term tutoring centers of SPACE, SPACE's joint marketing or business executing personnel, and legal investigation authority or competent authority.
- (4) Methods: By way of automatic machines or non-automatic measures.

### 4. According to Article 3 of the Act, you may exercise following rights with regard to your personal information collected by SPACE:

- (1) You may inquire and request for a review of your personal information, but SPACE may charge a necessary handlingfee.
- (2) You may request to make duplications of your personal information, but you shall duly explain the reason.
- (3) You may request to supplement or correct your personal information.
- (4) You may request SPACE to cease the collection, processing, or use of your personal information.
- (5) You may request SPACE to erase your personal information.
- (6) However, SPACE may reject your requests if the request is not consistent with the applicationprocedures, rules, SPACE has an obligation to keep, or the law provides otherwise.

### 5. The impact of nondisclosure of personal information:

You are in the position to decide whether to provide personal related information. However, SPACE may not be able to provide you with relevant services if SPACE can not process necessary review and handling procedures due to the lack of your personal information.

6. If the personal information you provided is reported or found insufficient to confirm the authenticity of your identity, unauthorized or impersonating uses, or incorrect, SPACE has the right to terminate your qualification for the membership and other related rights. The responsibility for this shall be borne by you.
7. If you want to change, inquire, supplement, correct or cease using your personal information, you may contact SPACE through the contact information disclosed on the SPACE official website, or you may directly go to SPACE studio to fill in the written application form. SPACE will continue to use the personal information provided by you for marketing and service before you request SPACE cease using your personal information.
8. For matters not specified in the Agreement, SPACE will follow the Act or applicable laws and regulations.
9. The English translation is only for reference, in the event of any discrepancy between the Chinese and English texts hereof and thereof, the Chinese version shall govern.
